### **OPENS THE APPLICATION PERIOD FOR THE RECOGNITION OF STRICTO SENSU POSTGRADUATE DIPLOMAS (MASTER AND DOCTORATE) ISSUED BY FOREIGN HIGHER EDUCATION INSTITUTIONS BY THE UNIVERSIDADE SÃO FRANCISCO – USF.**

The coordinator of the Stricto Sensu Post-Graduation Office at Universidade São Francisco – USF, in the use of her attributions, establishes the following

### **E D I C T**

**Art. 1.º** The period from April 20th to May 20th 2022 is open for applications of candidates for the recognition of Stricto Sensu Postgraduate diplomas (masters and doctorates) issued by foreign higher education institutions by Universidade São Francisco – USF.

**Art. 2.º** Registration must be made within the terms of this announcement exclusively through the Carolina Bori Platform, created by the Ministry of Education (SESu and CAPES) for the management and control of diploma recognition processes, at <http://carolinabori.mec.gov.br/>.


**§ 1.º** Applications will be accepted if the documents are sent through the Carolina Bori Platform until May 20, 2022 at 11:59 pm.

**§ 2.º** Before registering, the applicant should carefully read the information available at the Carolina Bori portal: <http://carolinabori.mec.gov.br/>.

**Art. 3.º** Information regarding Title I, Chapters II and III: the phases of the diploma recognition process, the registration and obligations of the interested party, the recognition process, the deadlines for appealing the denial of diploma recognition, and the examination commission are described in detail in CONSEPE Resolution 25/2021, which regulates the recognition of Stricto Sensu Postgraduate diplomas issued by foreign institutions of higher education by Universidade São Francisco – USF, available at: [www.usf.edu.br/galeria/getImage/410/109388445246148.pdf](http://www.usf.edu.br/galeria/getImage/410/109388445246148.pdf).

**Art. 4.º** The fees corresponding to the recognition of Stricto Sensu Postgraduate diplomas issued by foreign institutions are:

- I. document analysis fee in the amount of R\$ 280,00;



- II. academic analysis fee for the Master's degree in the amount of R\$ 9,100.00;
- III. an academic analysis fee for the Doctorate in the amount of R\$ 13,800.00.

**Art. 5.º** Openings will be offered for the following Stricto Sensu graduate programs:

- I. Stricto-Sensu Graduate Studies in Health Sciences (Master's Degree): 3 vacancies;
- II. Stricto-Sensu Graduate Studies in Health Sciences (PhD): 3 vacancies;
- III. Stricto-Sensu Graduate Studies in Education (Master's Degree): 3 vacancies;
- IV. Stricto-Sensu Graduate Studies in Education (Doctorate): 3 vacancies;
- V. Stricto-Sensu Graduate Studies in Psychology (Master's Degree): 3 vacancies;
- VI. Stricto-Sensu Post-graduation in Psychology (PhD): 3 vacancies.

**Art. 6.º** Cases not covered by this announcement will be evaluated and defined by the Pró-Reitoria de Ensino, Pesquisa e Extensão in conjunction with the Coordenação do Núcleo de Pós-Graduação Stricto Sensu.

**Art. 7.º** The interested parties and whoever may be entitled should be made aware of this so that it may take effect.
